Information on illegal animal transports on ferries from Varna, Bulgaria, to Batumi, Georgia from 24/07/2018 to 28/07/2018 and appeal to enforce the laws

Dear ministers and commissioner,

As lawyer and in-house-counsel of the German affiliate of the international, worldwide working animal rights organisation People for the ethical treatment of animals (PETA) it is my duty to inform you about <u>blatant infringements of European and most likely national law within your responsibilities in the field of animal welfare.</u>

We received photographs and a video from a person travelling on a ferry from Varna, Bulgaria, to Batumi, Georgia, from 24/07/2018 to 28/07/2018. On that ferry were several lorries with hundreds, if not a thousands of pigs on board. The lorries with the pigs already ascended the ferry on 23/07/2018. That means the animals spent five days within the lorries on deck of the ferry. You find the aforementioned pictures and the video as an

on a CD attached to this letter.

During that time the animals got no supply of water, food or medicine. Since the transport took place during the heat wave, the temperatures inside the lorries were up to 60°C, our contact person reports. Every day around 40 pigs died due to the lack of supply of their basic needs. They were disposed through throwing them over board into the sea, some of them still alive.

The described circumstances are <u>clear and blatant infringements of the EU-regulation EC No. 1/2005 on the protection of animals during transport and</u>

We therefore ask you kindly but clearly to take action against the obvious unacceptable conditions and the horrific suffering of the animals in your fields of responsibility.

We further kindly as you to inform us on your proceedings.
